Chair Carla Cross called the meeting to order at 8:36 a.m.

1. The meeting minutes from September 12, 2024, were approved unanimously after a motion from Andres Gonzalez, seconded by Mark Kessenich.

2. Chair Report

• Executive Committee Carla Cross shared that the Executive Committee met on December 5th and approved the board nominations and contracts from the GCN and Program Committees. The committee also approved recommendations for IT services and cost-sharing in front desk reception with Wisconsin Community Services. Annemarie provided a fiscal report which she will present this morning as well.

- Interim CEO & CFO Report Julie Cayo provided an update on the fundraiser, new grants and partnerships, WIOA reauthorization, and recent monitorings by the U.S. Department of Labor (DOL) and Wisconsin Department of Workforce Development (DWD). The fundraiser has generated almost \$60,000 in unrestricted funding thus far. WIOA may be reauthorized in the current session of Congress and a detailed list of changes is in the Board packet. DOL and DWD were on site this week for fiscal and programmatic monitoring, and it has gone very well. Representatives from both entities indicated they have no major concerns and are assured that Employ Milwaukee is well managed and headed in the right direction with operational changes made this year.
