Labor market from July to September, the WARN notes have increased, National Express Transit 144 worker, Master Lock 235 workers, Yellow Corp 85 workers. The summer youth employment programs both ended successfully. Earn & Learn served 1043 youth that had 117 different worksites. This year they had Enrichment workshops available for the youth and 250 youth participated in that as well as worked throughout the program. Camp Rise hired 34 camp counselors with a majority of those being MPS employees. The camp completed with 239 participants that experienced soft skills training, and filed trips to Discovery World, Havenswoods State Forest, Brewers Game, Incrediroll and Jones Island. Employer Engagement Updates, September 26 Franklin Business Park Job fair in conjunction with FlexRide, September 7 How to get a job in healthcare, 50 job seekers attended. **Executive Committee:** Andres reported that to stay compliant we have some new board members that we need to present to the Board of Directors. Ernest Jones who will also serve on the Governance Committee, and Ugo Nwagbaraocha who will serve on the Program Committee both will be additions to Board of Directors. Roderick Cureton who comes to us as Jakiem Jackson-Bells replacement from The Milwaukee Bucks. Carla moved to accept all the additions and changes to the Board of Directions, John Kissinger 2<sup>nd</sup> the motion, the board unanimously approved.

Executive Slate for approval, Carla Cross and Andres Gonzalez will move to the Board Chair and Board Vice Chair, that will fill the vacancies opened by Don Layden and John Kissinger stepping down. Carla will move to the Executive Committee and Board Chair, Andres Gonzalez will Vice Chair the Board and Chair the Personnel Committee, Edgard Delgado will Chair the Governance Committee, and Mark Kessenich will chair the Program Committee, Dr. Keith Posley will remain as chair for Youth Committee. Motion for approval John Kissinger moved, 2<sup>nd</sup> by Kevin Jeske, unanimously approved.

4. Chair John Kissinger reported that the PFA Committee has updated the 401k provider to The Standard which is under the Northwestern Mutual Umbrella, they will take over the fiduciary investment and administrator responsibility. In the future they will work on changing the 3% Safe Harbor match, did not have an opportunity to complete that task yet. Annemarie is getting settled into the position and this has caused some delay on the audit so that will be moved back to February. We are still working on the indirect cost rate, which is causing the agency a structural deficit, the agency is spending more than what they are bringing in, there was a reserve savings from the sale of the building, but we have had to tap into that. Have talked about an investment policy but have held back due to funds pulled to pay off the line of credit and the 200K that the agency borrowed that is working on paying back by the end of the year. The agency still has a lot to work on to get us in a sustainable place financially, we are in a much better place than where we were a few years ago. The fund develop is looking good, Julie Cayo shared that information with the board earlier.
